INTRODUCTION

This document is developed for Expi.trade clients or potential clients to provide them in good time information on all costs and related charges or fees. Such information relates to all Services provided by our Company when Client visit our website <https://expi.trade/> (the "Website"), and more generally, use any of our services (the "Services", which include the Website). Please refer to our Terms of Use for information what Services are provided to our Clients.

Expi.trade is not responsible for any fees and charges that may be applied by the Client's bank and/or financial institute.

KEY DEFINITIONS

"Administration fee" means commissions charged by Expi.trade Partners who provide our Platform with Digital Assets.

"Digital Asset" means EUR-EuPi, EuPi, BTC, ETH, EVER (TON) and other digital mediums of exchange that may be exchanged via the Services. Digital Assets are not accepted by a state owned central bank as a method of payment.

"Digital Asset Account" means any Digital Asset address or account owned or operated by Client that is maintained outside of the Services, and is not owned, controlled or operated by Expi.trade.

"Expi.trade Account" means a user account accessible via the Services where Digital Asset may be stored by Expi.trade i on behalf of a user.

"Deposit" means, pay in transaction from Digital Asset Account to Client's Expi.trade Account.

"Withdrawal" means, pay out transaction from Client's Expi.trade Account to Digital Asset Account.

"Minimum deposit amount" means that if Client will pay in amount less then Minimum deposit amount of Digital Assets to Client's Expi.trade Account Company will not process credit Client's Expi.trade Account unless the summarized amount of deposits exceed the Minimum deposit amount.

Deposit/withdrawal to/from Client's Expi.trade Account with any world currency which is not digital, i.e., the usual money which is in use in economy of any state not available and prohibited.
